Current position and responsibilities

I am Research Fellow of Philosophy at NMBU since 2011, where I have been Principal Investigator of two 10 million NOK research projects, Causation in Science (2011-2014) and CauseHealth – Causation, Complexity and Evidence in Health Sciences (2015-2019). I established the Philosophy of Science forum at the university in 2012, and the Centre for Applied Philosophy of Science (NMBU CAPS) in 2018. I have served as member of the Norwegian National Research Ethics Committees since 2017 and of the NMBU research ethics committee since 2014 (Deputy Leader since 2022). Inspired by this work, I established the NMBU Research Ethics Forum in 2022. I teach 3 courses: 'Examen Philosophicum: Introduction to Philosophy' in English (Bachelor-level), 'Interdisciplinarity and Expert Disagreement on Sustainability' (Master-level) and 'Research Education Across Disciplines' (PhD-level).

This is unusual in the Humanities, where we don't need a whole team to carry out different parts of a research project. When I work with others, we are equal authors, where each contributes equally to the work, intellectually and practically. This is possible because we use the Mumford Method for Academic Writing, which is particularly suitable for process-based writing and co-authoring. In an article in *Times Higher Education* on 16 December 2015, Stephen Mumford and I talk about how we have confronted suspicion and misconceptions of co-authorships.
